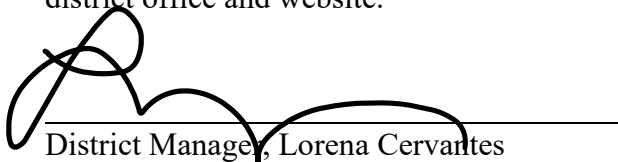
12. DIRECTORS' TIME:
